## MESSAGE FROM OUR PRESIDENT

Dear SMGA Member,

Welcome to the Senior Men's Golf Association for 2024! We have an exciting season planned for you on top tier courses in the Lowcountry.

How is this for kicking off the new year? – Hilton Head National, Atlantic Dunes, Harbour Town, Berkeley Hall, Palmetto Dunes Robert Trent Jones, Riverton Pointe, Arthur Hills, Moss Creek, Fripp Island Ocean Point, and Savannah Golf Club. And that's just our schedule through March! Additionally, we're returning to Country Club of Hilton Head, Oldfield (twice), The Landings (twice!), Long Cove Club and Cat Island.

For the most part, we will focus on Better Ball of Partners and 2 Best Balls of 4 formats, our most popular formats, with a couple of change ups thrown in.

Your Board diligently controls our costs to keep dues and tournament fees as low as possible as we focus on higher-end clubs. SMGA's revenue comes from our Registration Fee \$65 and Event Fee \$25 of which \$15 is returned in prize money and the remaining amount used for our Frequent Players Tournament, Bag handler fees and administrative fees.

In 2024, we will continue to use the Golf Genius App as our official scorecard. We will also ask each foursome to ensure that the paper scorecard agrees with the app by initialing or signing their name to the paper scorecard. Our goal is to identify prize winners quickly so they can collect their prizes the same day of the event.

Last year was the first time we used text messages to notify you of any event delays or cancellations. Text messages along with emails and web site announcements worked extremely well that we will continue with the same communication methods. If you have had any issues with this type of communication or if you made any changes to your contact information, please advise your Club Representative. The Club Representative listing is found on our web site [www.smgahhi.com](http://www.smgahhi.com) under the General Information tab.

You will find our Web site - [www.smgahhi.com](http://www.smgahhi.com) – is loaded with helpful information. And, as it relates to the Golf Genius TM system, please review the tutorials that will guide you through our event registration procedures.

There are several important considerations for Event registration.

1) You are required to enter your credit card information for each Event in which you register. Sorry, but for now Golf Genius does not want to be in the credit card vault business.

2) Registration for Events opens at 5 PM Eastern Time on the Thursday 11 days before the Event and closes at 11:59 PM the following Wednesday, 5 days before the event. We're striving to give everyone an easy opportunity to register for Events.

3) Event registration will continue be on a first come/first serve basis, so the sooner you register for an Event the greater your chance for getting entry. And please keep in mind if you are signing up for a Partners Event your team's registration is effective when the **second partner** completes his registration.

You can help us out a little bit:

1. Every year our Board experience openings as terms expire. We are always looking for members who are interested in joining the SMGA Board. If you are interested, please contact me directly at SMGA.president@gmail.com. I will be happy to go into details.
2. SMGA will post your scores at an Event to GHIN through the TM score keeping system as "Competition" scores. You need not post your scores.
3. The SMGA encourages a quick pace of play. Your position on the course should be pushing the group ahead of you, not holding up the group behind you.
4. Lastly and most importantly, our members are our best source of marketing to increase yearly memberships. Please tell your golfing buddies what a great organization you belong to and ask them to join you in 2024.

Keep in mind, the SMGA is designed for **YOU**, it's **YOUR** organization, and we want to make **YOUR** experience the best it can be. If you have suggestions, critiques or questions, each club has an SMGA Club Representative who can help you – please get to know him if you don't already. ### III. SMGA MEMBERSHIPS

#### 1. SMGA Memberships

**PLEASE NOTE:** Membership dues paid from the opening of registration to July 31<sup>st</sup> will cover the current year. Any new members joining August 1<sup>st</sup> or later in the calendar year will receive credit for both the remaining time in the current calendar year as well as the entire following year.

There are three membership requirements for joining the SMGA: you must have reached your 55th birthday, you must have a USGA Handicap Index of 24.0 or lower and you must be a member of an SMGA Recognized Club with active handicap services maintained at your home club.

#### 2. Types of club memberships that the SMGA recognizes:

- a. Annual Memberships at a SMGA Member Club with unlimited daily golf privileges for the calendar year and active handicap services at their Home club. (January 1 through December 31). The designated Club Representative is responsible to monitor the membership and active handicap services of the member and verify membership status no later than the first week of January of the new SMGA season. The Club Representative will notify the Membership Chairman in writing of any changes to the member's status prior to the start of the new SMGA season.
- b. Annual Memberships at a SMGA Non-Member Club with unlimited daily golf privileges for the calendar year and active handicap services at their Home club. (January 1 through December 31). The designated Club Representative is responsible to monitor the membership and active handicap services status of the member and verify membership status no later than the first week of January of the new SMGA season. The Club Representative will notify the Membership Chairman in writing of any changes to the member's status prior to the start of the new SMGA season. This SMGA Membership requires a 2/3 majority vote of the SMGA Board. This includes: The Legends at Parris Island, Savannah Harbor and Savannah Golf Club.
- c. Seasonal Memberships: Unlimited daily golf privileges for a specific period of time, with a specific start and end date. Seasonal Memberships would require a 2/3 majority vote of the SMGA Board for approval. If approved, the SMGA database would track the start and end date and terminate the eligibility on the last day of the approved time period. These members would be identified with a four-digit member number and active handicap services at their Home Club. If the member allows this package to expire or exhausts all golfing privileges, he will be suspended from SMGA events until golfing privileges are restored. The designated Club Representative is responsible to monitor the membership and active handicap services status of the Seasonal member and notify the Membership Chairman in writing of any changes in status.

- d. Out of Area Memberships: These members have unlimited daily golf privileges at a golf club not within Beaufort, Jasper or Chatham counties and have active handicap services at their home club. Out of Area Members would require a 2/3 majority vote of the SMGA Board for approval. These members would be identified with a four-digit member number. The designated Club Representative is responsible to monitor the membership and active handicap services status of the Out of Area member. If the member allows this membership to expire or exhausts all golfing privileges, he will be suspended from SMGA events until golfing privileges are restored. The Club Representative will notify the Membership Chairman in writing of any changes.
- e. SMGA will continue their relationship with Non-Member Clubs who do not offer Unlimited daily golf memberships, but have agreed to hosting an SMGA Event (e.g., Savannah Golf Club, Club at Savannah Harbor, Legends at Parris Island, Hilton Head National, Old South, Pinecrest) or for which SMGA would like to develop a relationship (Colleton River and Chechessee Creek).

#### **Not Recognized for Membership in SMGA**

- a. Multiple Play Rounds/Cards: These rounds or cards are purchased from a local golf club for a specific dollar amount and a specific number of limited rounds. The rounds/cards do not provide unlimited daily golf privileges. These rounds/cards are not an annual golf membership.
- b. Daily Golf Card (aka Punch Card): These cards are given to golfers by local clubs. The golfer does not purchase a specific number of rounds. The golfer pays for his round that day and his card is punched. Generally, there are 10 punches/rounds on the card. Some courses offer a free round once all 10 punches have been played. These cards do not provide unlimited daily annual golf privileges. The cards are not an annual golf membership.

## **IV. EVENT RULES AND REGULATIONS**

### **1. HANDICAPS**

- a. All handicaps must be based on Indexes in accordance with the current USGA Handicap System. The maximum handicap allowed in any event is 36.
- b. All members with a Handicap Index of 20.0 or higher will be required to play from the forward tees. This determination will be made prior to the beginning of our season (early January) or when the member joins the SMGA, whichever is last.

All handicaps used in an Event will be based on the current USGA Handicap Index on the day of the pairings (normally four days before the event) and as applied to the specific course being played.

- c. Course Handicaps will be calculated using procedures in the USGA Handicap Manual (Section 3). There are adjustments that will be applied to determine a player's final

Playing Handicap. The order in which these adjustments are applied is as follows:

- Calculate the Course Handicap (CH) of the player using the current USGA procedures.
- To determine the Playing Handicap, apply any percentage adjustment to the CH, rounding up with a .5 fraction or higher.

## **WORLD HANDICAP SYSTEM IMPACT ON SMGA EVENTS**

- 1) While there are a number of changes in handicap calculation and adjustment contained in the new handicap system in use from 1/1/20 forward, those highlighted below may have an impact on SMGA events. Note that there are two handicaps referred to below; the Course Handicap is your full handicap for that course and those tees selected in any given event, while the Playing Handicap includes the adjustment (usually 85%) recommended by the USGA for competitive events. Handicaps will be adjusted daily in the GHIN system but the SMGA will continue to use the handicaps on the day of pairings as the handicaps for the event except for handicap limited events.
- 2) There will be no maximum score per hole for the ball used as the recorded score for an individual or team. The net double bogey score limit (based on your Course Handicap) will apply for handicap score posting purposes, just as the Equitable Stroke Control process worked in the past, with the TM scoring system making that adjustment when it enters scores in GHIN.
- 3) When you will not factor in the hole, **we strongly encourage players to pick up**. To facilitate faster pace of play, the USGA has set scoring guidelines in this situation. They are: a) at 5 feet or closer to the pin, take 1 stroke; b) when between 5 feet and 20 yards from the hole, take 2 or 3 strokes based on what you deem appropriate; and c) beyond 20 yards from the hole, take 3 or 4 strokes as you deem appropriate.
- 4) The number of holes completed to be considered a postable round in 2024 is 9 holes. An expected Score Differential over the remaining holes will automatically be calculated to create an 18 hole score.
- 5) Course Handicaps will reflect the handicap index and slope adjustment as well as differences in course rating as related to par between the forward and regular tees, so no additional adjustment will be made in determining the Playing Handicap based on tee selection.
- 6) In the past, when posting a score in GHIN, you had to select Home, Away or Tournament as part of the process. The USGA did not encourage using the Tournament classification in most situations. The Tournament classification has been removed and a Competition classification has replaced it. The USGA is encouraging the use of the Competition classification in all organized events, which would include the SMGA events. Accordingly, starting in 2020, all SMGA events will be posted as Competition when TM enters those scores after an event.

## 2. ENTRY REGISTRATION AND PAYMENT / ACCESS TO TOURNAMENT MANAGER (TM) BY GOLF GENIUS

In order to use TM, a member must create an account with the TM system. This is a **one-time** registration and it is initiated when a member receives an email from the TM system and clicks on the link in that email. *NOTE: Your email address will be your “username” for the TM system.*

A member accesses TM by selecting the “**GOLF BALL**” on the home page of the SMGA web site (smgahhi.com). You will leave the “smgahhi.com” web site and be transferred to the SMGA Event Registration Portal that is part of the TM system, a separate web site.

- a. From the SMGA Event Registration Portal, use the “Sign In” link and enter your email address and password. Once you are signed in you select the “Event Schedule” link at the top of the page. Enter any **open** event by clicking on it. A description of the event, including format and cost will be available. If you choose to enter, follow the steps, including entering your credit card information, and **finish** the process. Once your registration has been completed and confirmed you will be added to the pending list for the event. No charges will be incurred unless you are selected to play in the event.

***Registration will be confirmed by an automated email telling you that you are registered for the event. The email will be sent from “noreply@golfgenius.com”. Please add this address to your approved sender list so that you will receive the emails. If you do not receive an email, you did NOT complete the registration process properly.***

- b. For 2-man partner events **both** members must enter the event separately and provide their partner’s name in the appropriate box. You can also have SMGA assign you a partner by indicating **NONE** in the partner box.
- c. For 4-man events, members will sign up as individuals and will be paired with other members to create a 4-man team.
- d. ***When you are selected to play in the event (usually 4 days before the event), an automated email will be sent to you confirming your entry and your fees for the event will be charged to your credit card. If you do not receive an email, then you are an alternate. Check the pairings posted on the web site to confirm your status.*** All players will be charged the “Event Fee” shown on the event registration description. When the event is played at the member’s “Home Club”, any discount will be determined by your club and the appropriate cart charge will be added to your club account by your club. The discount may not be the full amount shown as “Cart Fee” at some events, such as events where food is provided as part of the non-entry fee. A member’s “Home Club” is defined as the club that maintains the member’s USGA Handicap Index.
- e. Package and / or term members designated by a unique 4 – digit SMGA number pay full cart and entry fees at all SMGA Events. A member accesses TM by selecting the “**GOLF BALL**” on the home page of the SMGA web site (smgahhi.com). You will leave the “smgahhi.com” web site and be transferred to the SMGA Event Registration Portal that is part of the TM system, a separate web site.

- f. From the SMGA Event Registration Portal, use the “Sign In” link and enter your email address and password. Once you are signed in you select the “Event Schedule” link at the top of the page. Enter any **open** event by clicking on it. A description of the event, including format and cost will be available. If you choose to enter, follow the steps, including entering your credit card information, and **finish** the process. - k. Package and / or term members designated by a unique 4 – digit SMGA number pay full cart and entry fees at all SMGA Events.

### 3. DISTRIBUTION OF ENTRY FEES

- a. Entry fees are used to cover administration & amenity fees as well as prize money.
- b. Examples of administrative & amenity fees, which normally total \$10, include:
  - Frequent Players Tournament (at the end of the year).
  - Bag handler fees
  - Range ball fees
  - Credit card transaction fees
- c. The remainder of entry fees received for each Event shall be distributed in the form of prizes, as determined by the Event Chairman. This is normally \$15.
- d. After deduction of amenities and administration fees, the balance of entry money is distributed to approximately 20% of the players in the form of ***gift certificates at the course being played.***
- e. In those events having gross and net prizes, the winner of low gross will be awarded a gross prize, and he will not be eligible for any net prizes.
- f. Hole-in-one prizes will be awarded at the annual meeting.
- g. When an event is started but canceled before completion, the Event Chairmen will determine how and if prizes will be awarded.

### 4. EVENTS

- a. Pairing sheets will be posted on the SMGA web site (smgahhi.com) under the **EVENT INFORMATION** tab.
- b. Pairing sheets will contain relevant tee time / shotgun time, player groupings and other information pertinent to the event.
- c. Results of each Event will be posted on the SMGA website (smgahhi.com) under the **EVENT INFORMATION** tab. There are two ways to see event results:
  - i. **“Recent Results”** which provide a summary of all the events played this year.
  - ii. **“Credits”** - Detailed results are posted for each event that you entered. Just type your name in search bar, click on your name and then click on the event

The detailed results of events are also available for the current and prior month by clicking on the event sign up Golf Ball, signing in, clicking on the event desired and choosing Results.



## 5. HOW A MEMBER GETS SELECTED TO PARTICIPATE IN AN EVENT

**This section is intended to provide members with an understanding of the primary factors affecting a member's participation in an event.**

- a. When an event is undersubscribed, there is no issue related to selection. All members who register get in unless
  - i. It's a partner event and a member can register as an individual looking to be paired with another member for the event and there is no member to be paired with. See IV.2.d. above.
  - ii. A member named as a partner fails to register. In this case, the member who did register is disqualified. A disqualified member, at the discretion of the Event Chairmen, **MAY** still participate if:
    - There is a member who registered as an individual looking to be paired with another member, and
    - The disqualified member is willing to be paired with a member who registered as an individual. See IV.2.d. above.
    - The handicaps of the two players are within 10 strokes
  
- b. When an event is oversubscribed, several factors are considered when selecting who gets to play and who doesn't. Among them are:
  - i. When the number of registered players in an event is more than the maximum number of participants allowed, an Alternates list is created in the order in which members registered for the event.
  
  - ii. When an event is oversubscribed within the first 15 minutes of open registration, all those fully registered within that period, including partners/cart mates, will be entered into a random drawing for participation. Those not chosen will be placed on the Alternates list in the order in which they registered.
  
  - iii. Section Priority Event:
    - When an event is held at one of the premier courses in the area (eg: Harbour Town, Belfair, Long Cove, Berkeley Hall, etc.) the Board expects the event to be oversubscribed. For these events, the Board **MAY** designate, ahead of time, a Section priority for these events.
  
    - Each member receives a Section priority designation when he joins the SMGA. This designation never changes. Half of the membership has an A Section designation. Half has a B Section designation. You can find your designation on the website under General Information/Members List.
  
    - If an event has a Section priority designation (ie: A), those members with that designation will have priority for that event.

## NOTES:

In years when event designations are applied, for every A Section designated event the Board will strive to have a B Section designated event at another premier course and the Board can alternate the Section designation for those courses in the next year. In 2024, the Board has decided not to use section priority event designations.

1. SMGA Board members are given priority in events for the duration of their term and for one year after leaving the Board. This is in recognition of the time and effort they put into the SMGA and because their duties require them to be an Event Chairman for multiple events throughout the year, thus preventing them from being able to play in those events.
2. Effective in 2018, the Board changed the criteria for **initial** selection into an event to being based on a first come, first serve basis, with some exceptions for Board priority. Registration will open at 5:00 pm on Thursday eleven (11) days prior to the event and will close at 11:59pm on the following Wednesday. An Entry Number will be assigned based on the order a member completes his registration.
3. For Partner events:
  - a. Registration will be based on the time the 2<sup>nd</sup> partner registers (thus, completing the team's registration).
  - b. When a single player registers, he will be paired with another single registrant, both of whom will be prioritized based on time of registration and a maximum of 10 strokes difference in handicaps. See IV.2.d. above.
  - c. If your Partner withdraws from the Event and you still want to play in the Event, it is your responsibility to call the Event Chairmen.
  - d. You can always change your partner or status during the registration period but not after the registration closes.

#### **4. ALTERNATES**

- a. When an event is over-subscribed, an alternates list will be maintained. This list will be used to fill vacancies when a member, previously selected to participate in an event, has to withdraw. Player substitutions from the alternates list only occurs after the pairings have been made.
- b. When choosing alternates to fill vacancies, the Event Chairmen will attempt to use First Come/First Served (FCFS) order of entry as the priority. There may be situations where this would impact the integrity of the competition; e.g., in a 4-man event (A-B-C-D) substituting a 5 Handicap Index for a 22 Handicap Index. In these situations, the Event Chairs will choose the first alternate in order of entry that meets Handicap Index required to keep the competition balanced. Pairings will be done the day after registration is closed to minimize this issue.
- c. Below are some examples for Alternate selection.
  - i. In Individual events, the Event Chairs will call the first alternate based on first come/first served time of entry.
  - ii. In 2-man Partner events, the Event Chairs will call the first alternate individual who is within 10 Handicap Index strokes of the player being replaced. When replacing a team, the priority, on a FCFS basis, will be the same as before the pairings. See IV.2.d. above.
  - iii. In 4-man team events the Event Chairs will call the first alternate whose Handicap Index approximates that of the withdrawing player. The intent is to keep the teams as equal as possible in terms of low, middle and high Handicap Index player distribution, while honoring our priority to select players based on FCFS time of entry.

#### **5. SENIORS and SUPER SENIORS**

- a. The SMGA has two (2) divisions for its more senior members –
  - i. Seniors, age 70 to 74
  - ii. Super Seniors, age 75 or older.
- b. In order to qualify as a Senior or Super Senior, the member must have reached the requisite age on or before the day of that event.

## **6. CANCELLATION, WITHDRAWAL, LATE ARRIVAL, and NO SHOW**

Credits referred to in this section relate to the annual Frequent Players Tournament (FPT), a complimentary year end event at a premier club, including golf and lunch. 72 members are selected for this event based on participation throughout the year, with each event awarding 1 or more credits.

- a. A player who withdraws from an event prior to event registration closing, will not be charged for the event.
- b. A player who cancels after event registration has closed but before Noon on the Friday before the event will be charged an entry fee, but not a golf fee. He will receive no credit for the event. This applies even when the Event is subsequently canceled.
- c. NOTE THAT THE TIME OF WITHDRAWAL IS DETERMINED BY WHEN THE EVENT CHAIRMEN ARE NOTIFIED. PLEASE CONTACT THEM DIRECTLY.
- d. When members register for an Event as a 2-man team and one player cancels, the member canceling gets no credit and an entry fee is charged if they canceled after the registration closed but before Noon on the Friday before the event; after Noon of the Friday before the event, the canceling member will also be charged the golf fee. If the other member still wishes to play and notifies the Event Chairs, the Event Chairs will attempt to find a partner within 10 Handicap Strokes from the alternates list; if they are unable to do so, the player is removed from the event but gets credit for the event and the golf and event fee are refunded, and the team is replaced by a next team from the alternate list.
- e. If a player on a 4-man team has to withdraw, where an alternate is not available or after the match has started, the Event Chairman will assign a blind-draw partner of equal or close handicap from the foursome playing directly ahead or directly behind the foursome from which the member withdrew. The blind-draw partner's score will count for all 18 holes. If the blind-draw wins two team prizes, he can accept only the one with the highest value. In the case of 2-man teams, if the cancellation of a partner (late or withdraws) is just prior to the start of play, such that the remaining 2-man team would have to play alone, the remaining single will be allowed to play and a blind-draw will be assigned from the other team playing in the group. As with the 4-man team, the blind-draw can only collect one prize. 2-man teams that have a blind-draw will be eligible for prize awards.
- f. In the event a player is late for a starting time, he shall be disqualified from play in the scheduled event, and be charged both an entry fee and a golf fee, and no credit for the event will be given.
- g. Any player who notifies the Event Chairs of his cancellation or withdrawal after Noon on the Friday prior to the event will be charged both an entry fee and golf fee, and will receive no credit for the event.
- h. Any player who fails to appear for his scheduled tee time without having notified the Event Chairs of his cancellation or withdrawal will be considered a No-Show. He will be charged both an entry fee and a golf fee, and will receive no credit for the event. He will also receive a written reprimand for the first infraction and will be advised of membership cancellation on the second infraction occurring within the succeeding 12 months. This applies even when the event is subsequently canceled.
- i. If a player appears for an Event and withdraws because of an injury immediately prior to play or because of a change in playing conditions (walking or cart path only), the Event Chairs may request permission from the Board to refund the golf fee, so long as the Host Club has not been paid for the participant but will be charged the event fee. If the Host Club has been paid, the Event Chairs may assist the member in securing a playing credit. No SMGA credit will be given.

- j. If a player on the day of the event withdraws or fails to complete the event because of a non-medical or non-emergency issue, both an entry fee and a golf fee will be charged, and no credit will be given. When an event is for two days or more, a player must play the entire event to receive event credit, except in single elimination events. Failure to complete the event will be treated in accordance with paragraph (g) or (h) of this section.
  
- k. Onsite cancellation or stoppage of an event is to be determined by the Event Chairs in coordination with host golf club using the guidelines set forth in section 8.c.iii below.

To help clarify the rules outlined above, the following tables are provided.

i. When an event is held at a member's home club, no cart fee will be charged by the SMGA. The home club will charge the cart fee, where appropriate.

m. Additional Cancellation Guidelines

- i. If a member finds a substitute for a guest that cancels, then no additional costs are incurred by the member.
- ii. No credit will be given to a member who withdraws from an event that is subsequently canceled.



## 7. RULES FOR COMPETITION

- a. USGA rules govern all play, except when special local rules are posted by the Event Chairs.
- b. The SMGA Board has adopted several local rules to address pace of play issues:
  - i. Players who are out of the hole, and whose score will not be used, are encouraged to pick up and use the Most Likely Score guidelines.
  - ii. If a group falls 2 holes behind, the Event Chairs will issue a warning to them. If, after 20 minutes, the group has not noticeably improved their position on the course, the Event Chairs can instruct them to pick up, skip a hole and record a score of net double bogey on the hole(s) skipped for tournament scoring purposes. The TM system will adjust the score to net par for handicap purposes.
  - iii. The low handicap player of a group is the "Pace of Play Captain" responsible for his group's pace of play
  - iv. The Event Chairs have the authority to disqualify any team / group that fails to turn in a card within 4 hours and 45 minutes from the start of the event. They will give consideration to circumstances like where players started on the course, who was at fault for the slow play, etc.
- c. In 2019, the SMGA Board adopted three (3) additional local rules. They relate to:
  - i. Immovable Obstructions around the Green
  - ii. Balls lost or out of bounds
  - iii. Events Stopped or Canceled
- i. For immovable obstructions around the green (sprinkler heads, valve covers, etc.);

If the obstruction is in the intended line of play, is within two club lengths of the putting surface, and the ball is within two club lengths of the obstruction, the player will be given line of sight relief. The player may lift, clean and place the ball at the nearest point of relief, no closer to the hole, except it may not be placed on the putting surface
- ii. For balls lost or out of bounds;

### **The old rule...**

If a player hits a shot out of bounds or presumes his ball may be lost, he may replay the shot with a provisional ball and proceed with a potential stroke-and-distance penalty. If his original ball is, indeed, lost or out of bounds, he continues to play his provisional ball. If the player finds his first ball and it is in bounds, within the 3 minute timeframe, before hitting a shot beyond the point where the provisional ball came to rest he must abandon his provisional ball and play that first ball.

### **The new local rule is...**

*When a ball is presumed lost or out of bounds, the player may play a provisional ball, as in the past. Under the new local rule, he may search for the ball for 3 minutes and if not found, at his option, he may go to the edge of the fairway, nearest the vicinity where the ball was lost or last crossed out of bounds, based on*

*line of flight, no closer to the hole, and establish a line between that spot in the fairway and the hole. The player then measures two club lengths from that spot into the fairway; the drop area shall be between that spot 2 club lengths in the fairway and where the ball was lost or went OB, and as far back as he chooses, with a **penalty of 2 strokes** (eg: in the case of a drive lost or out of bounds, the player would be hitting **FOUR, just as he would be had he played a provisional ball to this spot**).*

**However, with this new local rule in place, A PLAYER MUST DECIDE IF HE WILL INVOKE THIS LOCAL RULE BEFORE LEAVING THE SPOT WHERE HE HIT THE SHOT IN QUESTION. IF A PLAYER OPTS TO HIT A PROVISIONAL BALL, HE ABANDONS HIS RIGHT TO INVOKE THIS LOCAL RULE.** Conversely, a decision NOT to hit a provisional ball, is a decision to invoke this local rule.

**NOTE:** For clarity:

*With this adopted local rule, an SMGA player can NEVER RETURN to the spot where he last hit his ball and play a provisional shot when he thinks his ball has gone out of bounds or now presumes it is lost.*

iii. For Events Stopped or Canceled;

In the event that play is suspended (eg: rain, lightning, or any other reason), **the maximum time that an event will be suspended prior to a decision being made to proceed with or to cancel / stop an event** (NOT necessarily the time that an event is restarted) will be between 60 and 90 minutes from the time the suspension is declared. The Event Chairs will determine the duration based on how much play has been completed and other factors.

After the EC-designated suspension time window, if it is determined that conditions, in the near term, will not be acceptable to resume play, the event will be stopped / canceled.

If an SMGA event is stopped or canceled, the following guidelines apply, based on an event's type of start (Shotgun or Tee Times) and when the event is stopped or canceled.

**a. Type of Start – Shotgun**

• **Situation #1 - Competition is canceled prior to the majority of players arriving at the host club for the event (eg: canceled the night before the event or canceled by email notification to all players the morning of the event.**

- No payments are made to the host club
- Tournament Chairman attempts to reschedule the event with the host club.
- All cart fees are refunded.
- The \$25 entry fee is refunded.
- A player does not receive credit for this event.

- **Situation #2 – Competition is canceled prior to the start of the event. But players are onsite.**
  - No payments for cart fees or prizes are made to the host club
  - Bag attendant gratuities are paid
  - Tournament Chairman attempts to reschedule the event with the host club.
  - All cart fees are refunded.
  - The \$25 entry fee is refunded.
  - A player does not receive credit for this event.
  
- **Situation #3 - All Players Complete 14 or More Holes**
  - Host club is paid for all players
  - Event chairmen (ECs) will apply equitable stroke control (ESC) guidelines to all incomplete holes.
  - No money is refunded to the player.
  - Unless all players have completed a par 3, the closest to the pin (CTP) pro shop credits or rounds of golf for that par 3 will not be awarded. This means ECs may give anywhere from 0 to 4 CTP awards.
  - In this case, if payment has already been made to the host club, the ECs will need to request a refund for any par 3 pro shop credits not awarded.
  - If rounds of golf (instead of pro shop credits) are **NOT** awarded for a particular par 3, the EC will keep the certificate for the rounds of golf and the SMGA will offer it as a door prize at the next Annual Meeting.
  - A player receives credit for having participated in this event.
  
- **Situation #4 – At least one (1) foursome DOES NOT COMPLETE at least 14 holes.**
  - In this situation, the event is considered canceled and the ECs have four (4) options.

**Option 1 - If the host club is willing to reschedule the event to one of the available rain dates;**

1. Bag attendant gratuities are paid.
2. No payment is made to the host club.
3. A player is refunded 100% of their cart fees
4. A player is charged \$7 (\$2 for gratuities and \$5 for administrative expenses) of his entry fee. \$18 (\$3 for the FPT, and \$15 for prizes) is refunded.
5. A player receives no credit for having participated in the event

**Option 2 - If the host club gives all participants rainchecks;**

1. Bag attendant gratuities are paid.
2. Host club is paid for all players
3. A player is charged the full amount for cart fees and entry fees.
4. A player receives credit for having participated in the event

**Option 3 – All players have played at least seven (7) holes but not ALL played have played fourteen (14) holes;**

1. Bag Attendant gratuities are paid.

2. EC negotiates the percent of cart fee to be paid to the host club.
3. A player is charged the appropriate percent of the cart fee, reflecting the arrangement negotiated with the host club.
4. A player is charged \$10 (\$2 for gratuities, \$5 for administrative expenses, and \$3 for the FPT) of his entry fee. \$15 (for prizes) of his entry fee is refunded.
5. A player receives credit for having participated in this event.

**Option 4 – Most players have played six (6) holes or less:**

1. Bag attendant gratuities are paid.
2. EC negotiates the percent of the cart fee to be paid to the host club, with a goal of no payment.
3. A player is charged the appropriate cart fee, reflecting the arrangement negotiated with the host club.
4. A player is charged \$7 (\$2 for gratuities and \$5 for administrative expenses) of his entry fee. \$18 (\$3 for the FPT, and \$15 for prizes) of his entry fee is refunded.
5. A player receives no credit for having participated in the event

**b. Type of Start – Tee Times**

**• *Situation #5 - Competition is canceled prior to the majority of players arriving at the host club for the event (eg: canceled the night before the even or canceled by email notification to all players the morning of the event.***

- No payments are made to the host club
- Tournament Chairman attempts to reschedule the event with the host club.
- All cart fees are refunded.
- A player is charged \$5 of his entry fee for administrative expenses. \$20 (\$2 for gratuities, \$15 for prizes, and \$3 for the FPT) is refunded.
- A player does not receive credit for this event.

**• *Situation #6 – Competition is canceled prior to all players teeing off.***

- No payments for cart fees or prizes are made to the host club
- Bag attendant gratuities are paid. *The EC determines if this is \$1 or \$2 depending on when the event is canceled.*
- All cart fees are refunded.
- A player is charged \$6 or \$7 of his entry fee (\$1 or \$2 for gratuities and \$5 for administrative expenses). \$19 or \$18 (\$15 for prizes, \$3 for the FPT, and possibly \$1 for gratuities) is refunded.
- A player does not receive credit for this event.

**• *Situation #7 - All Players Complete 14 or More Holes***

- Host club is paid for all players
- Event chairmen (ECs) will apply equitable stroke control (ESC) guidelines to all incomplete holes.
- 
- No money is refunded to the player.

- Unless All players have completed a par 3, the closest to the pin (CTP) pro shop credits or rounds of golf for that par 3 will not be awarded. This means ECs may give anywhere from 0 to 4 CTP awards.
- In this case, if payment has already been made to the host club, the ECs will need to request a refund for any par 3 pro shop credits not awarded.
  - If rounds of golf (instead of pro shop credits) are **NOT** awarded for a particular par 3, the EC will keep the certificate for the rounds of golf and the SMGA will award it as a door prize the next Annual Meeting
  - A player receives credit for having participated in this event.
- **Situation #8 – At least one (1) foursome DOES NOT COMPLETE at least 14 holes.**
  - In this situation, the event is considered canceled and the ECs have four (4) options;

**Option 1 - If the host club is willing to reschedule the event to one of the available rain dates:**

1. Bag attendant gratuities are paid.
2. No payment is made to the host club.
3. A player is refunded 100% of their cart fees
4. A player is charged \$7 (\$2 for gratuities and \$5 for administrative expenses) of his entry fee. \$18 (\$3 for the FPT, and \$15 for prizes) of his entry fee is refunded.
5. A player receives no credit for having participated in the event

**Option 2 - If the host club gives all participants rainchecks:**

1. Bag attendant gratuities are paid.
2. Host club is paid for all players
3. A player is charged the full amount for cart fees and entry fees.
4. A player receives credit for having participated in the event

**Option 3 – All players have played at least 7 holes but not ALL played have played 14 holes:**

1. Bag attendant gratuities are paid.
2. EC negotiates the percent of cart fee to be paid to the host club.
3. A player is charged the appropriate percent of the cart fee, reflecting the arrangement negotiated with the host club.
4. A player is charged \$10 for administration fees (\$2 for gratuities, \$5 for administrative expenses, and \$3 for the FPT). \$15 of a player's entry fee is refunded.
5. A player receives credit for having participated in the event.

**Option 4 – Most players have played six (6) holes or less:**

1. The Bag Attendants are paid
2. The EC negotiates the percent of cart fee to be paid to the host club, with a goal of no payment.
3. A player is charged the appropriate percent of the cart fee, reflecting the arrangement negotiated with the host club.

4. A player is charged \$10 for administration fees (\$2 for gratuities, \$5 for administrative expenses, and \$3 for the FPT). \$15 of a player's entry fee is refunded.
5. A player receives credit for having participated in the event unless all 100% of their cart fees have been refunded. In this case, a player receives no credit.

### **Additional Rules for Competition**

- The decision of the Event Chairmen shall be final.
- All putts must be holed for the scores to be used in competition for the team or the individual, except in match play.
- No member shall enter a match play event unless prepared to play all matches in the event.
- Score cards are to be kept by opposing teams or individuals except in 4-man team events. Cards shall be signed or initialed and attested and delivered to the scoring area when play is completed. The use of the TM scoring app on mobile phones is required to improve the speed of event completion as well as being the official score. Your initials on the scorecard indicate that you agree with the Golf Genius score on the mobile app and will be used as your official score. If the scorecard is not turned in with initials, you and your team will be disqualified.
- DISTANCE-MEASURING DEVICES - As provided in USGA Rule 4-3, the SMGA has adopted a Local Rule for all SMGA events whereby a player may use a distance-measuring device to obtain distance information **only**. If, during a stipulated round, a player uses features of a distance-measuring device that measure other conditions that might affect his play (e.g., gradient, wind-speed, temperature, etc.), the player is in breach of Rule 4-3, for which the penalty is disqualification, regardless of whether any such additional information is actually used. Conforming devices may be shared by players.
- Forward Tees will be permitted for most SMGA events. Handicap adjustments will be made based on criteria defined in section IV.1.c. Members must declare at the start of the season their intention to play forward tees and they will not be allowed to change during that year without approval of the Board. Members selecting to play from the regular tees must have a Handicap Index below 20.0.
- In any Event, the local club or the SMGA Event Chairmen may establish a local rule to speed play or clarify an existing ruling.

- Exposed Root Rule

This root rule has been established to prevent personal injury from tree roots that are exposed from the normal trunk of a tree. This rule is for swing relief only and not for stance relief.

a) Notify your opponent(s) or playing partners.

b). Take relief by placing the ball in a spot that insures complete swing relief from the exposed root and no closer to the hole.

c). The allowable relief is to be no greater than the distance required to have complete swing relief from the exposed root.

d). Interference by exposed root with your stance is not a reason for relief under this rule.

e). Exposed root relief does not apply within a marked penalty area. If you elect to take relief from exposed roots within a marked penalty area, you must declare an unplayable and then take the appropriate relief, along with your 1 stroke penalty.

## 8. EVENT DESCRIPTIONS

### a. Four (4) Man Team Play

#### i. Two (2) Better Balls of Four (4)

- **Definition** – An event where the teams are comprised of 4 players and the two best net scores on each hole is the team's score.
- **Pairings** – Pairings will be made by the computer such that each 4-man team has a total handicap that results in balanced team handicaps within their flight.
- **Handicap** – Course Handicaps will be calculated using the procedures defined in section V.1.c above with a 85% adjustment applied to all players.
- **Flights** – The field will be split into two (2) flights of about the same size based on the player's index. All teams in a flight will be comprised of players with a handicap index within the range established for their flight and will compete for prizes against other teams in that flight. Although an Event Chairman will try to avoid this, it is possible that an alternate may have a handicap index outside the range of the rest of the flight.
- **Duration** – All events are one day events consisting of one 18 hole round.
- **Prizes** – Prizes will consist of pro shop credits and will be awarded to about 20% of the players in the event.
- **Scoring** – The net score of each player will be calculated and the two best net scores on each hole will be used as the team's score. The lowest net team score within a flight will determine the winner(s). If there are ties, see Section 12 below.

#### ii. Better Ball Variations

- **Definition** – An event where all of the sections of the “2 Better Balls of 4” description apply except for the “Scoring” section (see below).
- **Scoring** – There are three (3) variations of scoring that can be used for the Four Man Team Play events:
  - i. **1 – 2 – 3** – The net score of each team will be calculated using: one best net score on the Par 3 holes; two best net scores on the Par 4 holes; and three best net scores on the Par 5 holes. The lowest net team score within a flight will determine the winner(s). If there are ties, see Section 12 below.
  - ii. **3 – 2 – 1** – The net score of each team will be calculated using: three best net scores on the Par 3 holes; two best net scores on the Par 4 holes; and one best net score on the Par 5 holes. The lowest net team score within a flight will determine the winner(s). If there are ties, see Section 12 below.
  - iii. **6– 6–6** – The net score of each team will be calculated using: one best net score on holes 1 through 6; two best net scores on holes 7 through 12; and three bestnet score on holes 13 through 18. The lowest net team score within a flight will determine the winner(s). If there are ties, see Section 12 below.
  - iv. **Four man scramble**- All players tee off, the preferred tee shot is chosen and all players play from within one club length of that location in the general area and 6” on the green (within the same condition – e.g., fairway/ rough/ penalty area, etc.), continuing until the ball is holed. The gross score is recorded for each hole and reduced by the assigned handicap when the score is totaled.
  - v. **Four man step-aside scramble**- The same format and scoring as the four man scramble is used, except that the player who struck the preferred shot is excluded from the rotation for the next shot.

## b. Two (2) Man Team Play

### i. Better Ball of Partners - Stroke play / Better Ball of Partners – Shamble.

- **Definition** – Stroke play; an event where the teams are comprised of 2 players, each playing their own ball, and the one best net score on each hole is the team’s score. Shamble; both players tee off, they choose the preferred tee shot and both play their own ball from that location into the hole, choosing the best net ball as the team score.
- **Pairings** – Players can identify their desired partner during the registration process, or can register as an individual and they will be paired up with another individual to form a team (see IV.2.d. above). When two members want to play as a team, they must each register for the event and identify the other as their partner to be properly paired as a team (for Guest Day procedures, see the Notes section below).
- **Handicap** – Course Handicaps will be calculated using the procedures defined in section V.1.c above with a 85% adjustment applied to all players in the Stroke play format, and a 75% adjustment for all players in the Shamble format. In the event of



a difference of greater than 10 strokes in the team member's course handicaps after the above adjustments are made, a further adjustment will be made to the higher handicap to limit it at 10 strokes above the lower handicap.

Two of the events are restricted based on their Handicap Index. One of the events is for members with a lower handicap Index of **14.0** or less and the other for members with a Handicap Index of **14.1** or greater. The actual values for each event are reviewed and determined annually. Both team members must meet this Handicap Index requirement at the time of registration closing to be paired as a team.

- **Flights** – The field will be split into flights based on the total Handicap Index of the two team members so that each flight will contain about 8 teams. Teams will compete for prizes against other teams in that flight.
- **Duration** – All events are one day events consisting of one 18 hole round.
- **Prizes** – Prizes will consist of pro shop credits and will be awarded to the first and second place team in each flight of the event. **Scoring** – The net score of each team member is calculated for each hole and the best net score for each hole is the team score. The lowest net team score within a flight will determine the winner(s). If there are ties, see Section 12 below .
- **Guest Day Events** – Some of the events using this format may be designated as “Guest Day” events. SMGA members can invite a guest as their partner provided that individual:
  - i. Is 55 years of age or older and
  - ii. Has a USGA Handicap Index of 36 or less, verifiable through the GHIN System or a Golf Association licensed by the USGA to maintain the Handicap Index.
  - iii. **For Guest Day event registration**, the SMGA member must identify the guest's name, their GHIN number, the tee they will use for the event (regular or forward) and pay the entry and cart fee for the guest on the member's credit card. A guest selecting the regular tees must have a Handicap Index below 20.0.

## ii. Better Ball of Partners (Stableford play)

- **Definition** – An event where all of the sections of the “Better Ball of Partners (Stroke Play)” description apply except for the “Scoring” section (see below).
- **Scoring** – The net score of each team member is calculated for each hole and that score is compared to par for that hole to determine the Stableford points for each player. The higher of the two player's points on the hole will be their team score. The Stableford points for the net score compared to par are: Double Bogie or worse 0, Bogie 1, Par 2, Birdie 4, Eagle 6, and Double Eagle 8. The highest team score/points within a flight will determine the winner(s). If there are ties, see Section 12 below.

### iii. Better Ball of Partners (Chapman play)

- **Definition** – An event where the teams are comprised of 2 players and the two methods of calculating the team score for are described in the “Scoring” section below.
- **Pairings** – Players can identify their desired partner during the registration process, or can register as an individual and be paired up with another individual to form a team (See IV.2.d. above). When two members want to play as a team, they must each register for the event and identify the other as their partner to be properly paired as a team
- **Handicap** – For this format of play, two different methods of calculating the team handicap are used as follows:
  - For the Better Ball of Partners play - Course Handicaps will be calculated using the procedures defined in section V.1.c above with a 85% adjustment applied to all players. For a one day event, this handicap is used on the front nine. For a two day event, this handicap will be used for round 1.
  - For the Chapman play - Course Handicaps will be calculated using the procedures defined in section V.1.c above with the team handicap calculated by using a 60% adjustment applied to the player with the low handicap and a 40% adjustment applied to the player with the high handicap. When these percentages are applied, the handicap will be rounded to include one decimal. This team handicap is then subtracted from the team’s gross score for the holes played under the Chapman format. For a one day event, one half (50%) of this handicap is used on the back nine gross score and the full team handicap will be used for round 2 of the two day event.
- In the event of a difference of greater than 10 strokes in the team member’s course handicaps after the above adjustments are made, a further adjustment will be made to the higher handicap to limit it at 10 strokes above the lower one.
- **Flights** – The field will be split into flights based on the total Handicap Index of the two team members so that each flight will contain about 8 teams. Teams will compete for prizes against other teams in that flight.
- **Duration** – The event can be a one day event consisting of one 18 hole round with a different method of scoring on the front nine (Better Ball), and the back nine (Chapman), or a two day event consisting of two 18 hole rounds with a different method of scoring used for each round.
- **Prizes** – Prizes will consist of pro shop credits and will be awarded to the first and second place team in each flight of the event.
- **Scoring** – For a one day event, holes 1 through 9 are scored using a Better Ball of Partners system and holes 10 through 18 are scored using a “Chapman” system. For the two day event, one complete 18 hole round is scored using the same system with Better Ball play on day one and Chapman play on day two. The scoring is as follows:

- i. Better Ball of Partners - The net score of each team member is calculated for each hole and the best net score for each hole is the team score.
- ii. Chapman Pay. Each player hits his tee shot, each player then hits his partner's ball. The team then selects one ball and alternates shots until the ball is holed. Record the gross score on the hole as the team score. Team Handicap will be deducted from the total gross score for the Chapman portion of play.

## c. Individual Play

### i. Individual Stableford Play

- **Definition** – An event where the players in the event are maintaining their scores as individuals and their net score on each hole is converted to a point value as described in the “Scoring” section below.
- **Pairings** – Each player maintains an individual score for the event and the groups of four players is determined by the computer.
- **Handicap** – Course Handicaps will be calculated at 95% using the procedures defined in section V.1.c above.
- **Flights** – The field will be split into flights based on the Handicap Index of the player so that each flight will contain about 8 players. Players will compete for prizes against other individuals in that flight.
- **Duration** – All events are one day events consisting of one 18 hole round.
- **Prizes** – Prizes will consist of pro shop credits and will be awarded to about 20% of the players in the event.
- **Scoring** – The net score of each player is calculated for each hole and that score is compared to par for that hole to determine the Stableford points for that hole. The Stableford points for the net score compared to par are: Double Bogie or worse 0, Bogie 1, Par 2, Birdie 4, Eagle 6, and Double Eagle 8. The highest score/points within a flight will determine the winner(s). If there are ties, see Section 12 below.
- **Notes** – One of the Individual Stableford events is designated as a “Super Senior” event. The field for this event is divided into two or three flights based on age with first flight being members 75 and older (Super Seniors), a second flight being members 70 through 74 years old (Seniors), and a third flight, if offered, being members age 69 and younger (all other players). Players within a flight compete with all players in that flight for prizes. Handicaps for all flights are calculated using the procedures defined in section V.1.c above. All players in a flight play from the same tees. Prizes will be awarded to about 20% of the players in the flight.

### ii. Individual Stroke Play

- **Definition** – An event where the players in the event are maintaining their scores as individuals using their net score on each hole.
- **Pairings** – Each player maintains an individual score for the event and the groups of four players is determined by the computer.
- **Handicap** – Course Handicaps will be calculated at 95% using the procedures defined in section V.1.c above.

- **Flights** – The field will be split into flights based on the Handicap Index of the player so that each flight will contain about 8 players. Players will compete for prizes against other individuals in that flight.
- **Duration** – All events are one day events consisting of one 18 hole round.
- **Prizes** – Prizes will consist of pro shop credits and will be awarded to the first and second place player in each flight of the event.
- **Scoring** – The net score of each player is calculated for each hole and that score is totaled for the 18 hole round. The lowest net score within a flight will determine the winner(s). If there are ties, see Section 12 below.
- **Notes** – This format is used for events during the year and for the SMGA's end of season invitational event titled the "Frequent Player Tournament " with invitations extended to members based on the total number of playing credits accumulated over the entire season. At every event during the season, a portion of the entry fee from every player is designated for use for this event. The total number of invitations that will be extended will be determined by the BOG based on the funds available for the event, but is usually 72.

### iii. Individual Match Play

- **Definition** – An event where players play 18 hole matches with the goal of winning individual holes against their opponent. The player who wins the most holes wins the match.
  - **Pairings** – Each flight, except the Championship flight, consists of four players. Flights are determined by handicap Index. The eight (8) players having the lowest handicap indexes will be designated the Championship Flight and will play from tees approximating 6,200 yards. All players in the Field Flights will play from the same tees (about 5,800 yards). Each foursome will consist of two (2) matches – 2 players playing 1 match, 2 players playing another match.
  - **Handicap** –The players in the Championship Flight will play at "scratch" (no strokes). Players in the Field Flights will play off the lowest handicap player in the flight. For the Field Flights and the Consolation game, course handicaps will be calculated at 95% using the procedures defined in section IV.1.c above.
  - **Flights** – There can be no more than 14 flights and 60 players in the combined Championship and Field flights.
  - **Duration** – Match play Championship flight winners are determined over a 3-day event. For all other flights, the winners are determined over a 2 day event. The Consolation game is a 1-day event.
- Day 1: Winners of each match will move to the next round on Day 2. Losers of each match (of both the Championship Flight and the Field Flights) will play in a flighted low net, stroke play Consolation game on Day 2. The Consolation game players will be split into two (2) flights, by handicap.

Day 2: Championship winners of each match will move to the next round. For all other flights, the winner of each flight is determined on the second day. Consolation game winners are done after Day 2.

Day 3: Championship Flight Finals.

**Prizes** – Prizes will consist of pro shop credits and will be awarded to the Flight Winner and runner-up in each flight. Prizes will also be awarded to Consolation game winners and runners-up in each of the two (2) flights.

- **Scoring** – Match Play scoring will be used for the match play events. Stroke Play scoring will be used for the Consolation game. For ties, see Section 12 below.
- **Notes** – The fee for this event includes a lunch which will be provided after play on each day of the event. If a player withdraws from the event, his opponent will be declared the winner of the match and he will move onto the next day (next round of match play).

## 9. FREQUENT PLAYERS' TOURNAMENT

- a. At the end of each year, SMGA holds a "Frequent Players' Tournament" now known as the **Richard Robertson Memorial Championship** to reward those players who have accumulated the most playing credits. Credits are awarded to players for every tournament they participate in. Each year the Board will determine the size of the field of this event and those players who meet the criteria will be invited to participate in the tournament (number not to exceed 72). There will be no cart fee or food charge for this event; the only fee will be for the prize pool.

## 10. TIES

- a. In the event of a tie, winners will be determined by a match of cards (MOC). The best score on the back nine holes (#10 - #18 inclusive) will be used. If the players (or teams) remain tied, then the winner is determined using the last six holes, then the last three holes, and then the 18th hole. If the players (or teams) remain tied, then the same procedure will be applied to the front nine holes. If a tie still remains, the winner will be determined by using the #1 handicap hole first, #2 handicap hole 2<sup>nd</sup> and so on until there is a winner.

## 11. PACE OF PLAY

- a. The SMGA is a "Ready Golf" organization and promotes "ready golf" not "rushed golf". We ask that you be ready to play while using common sense and good etiquette on the course.
- b. If a group falls more than two holes behind, the Event Chairmen will issue a warning to them. If after 20 minutes, the group has not noticeably improved their position, the Event Chairs can instruct them to skip ahead and record a net double bogie for the hole(s) skipped. This will be adjusted to net par if the scores are entered in GHIN. This decision is to be made at the ECs discretion.
- c. The Event Chairs reserve the right to place chronic slow players at the end of the field.

Continued slow play or action contrary to the rules of golf could result in disciplinary action by the Board of Governors, including loss of membership.

## 12. SMOKING POLICY

- a. Please refrain from smoking if your playing partner(s) objects.
- b. Please refrain from smoking in common areas (driving range, putting green, etc.).
